ADI 21S - Notes For Guidance

For the duration of your trainee licence, you must keep a record of the number of hours you spend giving driving instruction and the number of hours you are directly supervised by an Approved Driving Instructor. You must be supervised for at least one fifth of the time you give instruction during this period (See the booklet ADI14 for further details. It is enclosed in the ADI Starter Pack).

This record must be clearly set out, legible and unambiguous.

Remember: It is an offence to make a false declaration. If you did not receive this supervision you should not sign this form.

Please be aware that waiting times for Part 3 tests may vary between test centres. It is advisable to take into account the local availability of tests when planning to apply for your test.

Processing your personal data:

The Driving Standards Agency (DSA) directly manages all personal data it processes as an executive agency of the data controller, the Department for Transport.

We do not disclose or share personal data with any third parties other than in line with the Data Protection Act 1998. This may include, but is not restricted to, disclosure to the police, HM Revenue and Customs, local governments and DVLA. In the case of transfers from DVLA, this may include details of endorsements for the purpose of ensuring that registered ADIs continue to be fit to remain on the register.
